# Nottinghamshire Youth Justice Service Practice Guide to Integrated Offender Management

#### Introduction

Integrated Offender Management (IOM) brings a cross-agency response to the crime and reoffending threats faced by local communities. The most persistent and problematic offenders are identified and managed jointly by partner agencies working together.

Local IOM models will vary to reflect local circumstances and priorities. In Nottinghamshire, the IOM scheme targets the most violent and risky offenders, including perpetrators of domestic abuse and those who use weapons.

The majority of IOM Nominals in Nottinghamshire are adults; however, the scheme is open to young people, and the Youth Justice Service (YJS) are one of the IOM partners.

#### IOM Offer for Young People

As the YJS is already a cross-agency partnership working jointly to respond to young people who are at risk of committing, or whom commit crime, the IOM model for under 18's in Nottinghamshire, is to support and add to the existing YJS offer.

If a young person is accepted onto the IOM Scheme and becomes an IOM Nominal the following will be made available:

- Daily intelligence check which will be flagged to YJS Police colleagues who will pass on relevant information to the Case Manager.
- Additional support, checks, and visits to young people whilst they are managed under mandatory licence or other supervision conditions, are conducted by the YJS PC/PCSO or Police staff member with the designated Police powers, as provided by the YJS Police Sergeant.
- Enhanced Police and YJS enforcement around breaches of supervision to robustly manage the young person's identified Threat, Risk and Harm.

#### **Identification and Referrals to IOM**

Youth Justice Case Managers can make a referral to IOM by completing the IOM Referral Form which can be found in the 'Referrals to others' folder on Sharepoint and sending this to the MAIT (Multi-Agency Intelligence Unit).

The MAIT score the referral based on a Matrix (see appendix A), and those scoring 15 +, <u>or</u> where there is a significant intelligence picture irrespective of the score, these will be discussed at the IOMS (Integrated Offender Management Selection) Meeting. This is a Multi-Agency meeting chaired by the IOM Inspector and attended by partner agencies.

All Case Managers are to consider whether a referral to IOM is appropriate when allocated young people who meet the criteria detailed in appendix A.

## Joint YJS and Police working arrangements.

- All young people who are IOM nominals will be secondary allocated to the YJS PCSO and have an IOM Programme added to the appropriate YJS Case management recording system.
- Case Managers should liaise with the YJS PCSO to agree contacts levels, use of IOM visits for statutory contacts etc based on risk and need.
- The YJS PCSO should be invited to Case Management Meetings for any IOM nominals.
- Young People who are subject to IOM will be discussed at IOM case review meetings.
