Safeguarding Adults

Basic Awareness

➤ Suitable for:

The course is suitable for all staff and volunteers that have contact with adults within Kirklees who may be at risk of abuse or neglect. It will provide participants with a basic awareness of adult safeguarding, which is a minimum requirement for everyone either as a volunteer or employee.

This learning enables staff and volunteers to gain the knowledge and skills to work in a personalised way to prevent and recognise safeguarding concerns and to know what to do when concerns arise.

➤ At the end of the course participants will be able to:

- Recognise adults in need of Safeguarding and take appropriate action in a way that respects the rights, equality and diversity of the individual concerned and promotes the principles of Making Safeguarding Personal
- Discuss your understanding of dignity and respect when working with individuals
- Have knowledge of the policy, procedures and legislation and know the procedures for reporting a Safeguarding Concern
- Ensure effective administration and quality of safeguarding processes
- Know what to do if you suspect any adult is at risk of abuse or neglect or is being abused or neglected

KSAB Joint Multi-agency Safeguarding Adults Policy and Procedures

Module 1 and Module 2

Module 1: Introduction to safeguarding principles and role of the enquiry officer (empowerment and proportionality)

Module 2: Working with adults at risk with complex needs (prevention and protection) for anyone who has completed module 1 and is working with complexity

➤ **Suitable for:**

Any staff who has to undertake an enquiry under the multi-agency policy and procedure and how this fits within the wider legal framework governing safeguarding responsibilities, including duties owed by regulators, employers, commissioners. It will offer practical guidance on applying an asset-based, person centred approach and practical considerations of evidential burdens and legal obligations owed to Adults at risk, and persons alleged to have caused harm when responding to allegations of abuse or neglect.

➤ **At the end of the course participants will be able to:**

- Enhance critical understanding of the legal considerations when undertaking safeguarding enquiries, including distinguishing between evidential burdens for criminal and civil law,
- Provide an overview of Court structure and review options re protection planning, preventing reoffending and providing restorative justice
- Develop practice-based knowledge of the multi-agency safeguarding policy and procedures in relation to the role of the enquiry officer
- Enhance core practitioners' skills re critical analysis, interviewing, managing confrontation and defensible decision making within safeguarding enquiries
- Navigate the policy framework and local procedures to enable effective multi-agency shared risk management.

Module 3

Module 3: Safeguarding Adults – Role of the Co-ordinator - introduction to managerial oversight of safeguarding (partnership and accountability)

➤ **Suitable for:**

Team managers and senior practitioners who may be required as part of their role to co-ordinate a safeguarding adult's enquiry and hold a planning and outcomes meeting. **Please note** you must have completed modules 1 & 2
The course will be delivered via MS Teams through a mixture of presented materials complemented by opportunities for discussion and case studies. Practitioners undertaking the Safeguarding Coordinator's role will explore how the multi-agency policy and procedure fits within the wider legal framework. It will also offer an opportunity to reflect on practical steps practitioners can take when preparing, chairing and following up from meetings to secure improved outcomes for Adults at risk.

➤ **At the end of the course participants will be able to:**

- Understand the roles and statutory responsibilities of practitioners working across the partnership
- Realise MSP principles, how these reinforce core social work professional values and conquer common barriers to the practical application of these
- Enhance core practice skills re critical analysis and defensible decision making, taking into account the legal complexity required for successful safeguarding interventions
- Develop practice based knowledge of the multi-agency safeguarding policy and procedures, by exploring positive practice examples of asset based, legally literate approaches.

Safeguarding Adults Concerns manager

➤ **Suitable for:**

This course will support senior staff and managers of provider organisations to consider their roles in leading their organisations when a 'statutory safeguarding enquiry' is taking place relating to their customers/clients/patients. Residential or Nursing Care Homes, Home Care agencies, Statutory Agencies such as Police, Health Trusts, Voluntary agencies, Social and Health Care workers, Advocacy groups, Faith communities in Kirklees. The course will provide organisations with guidance on the role of the Safeguarding Concerns Manager who will be responsible for deciding whether to report suspected abuse or neglect as a safeguarding concern.

Learning from Reviews and how the learning may affect / change the way in which you work with people, is an important aspect for anyone working or volunteering with Adults and Children. We want to significantly reduce the risk of people dying or suffering serious life changing abuse or neglect.

➤ **Suitable for:**

An open invitation to all partner organisations for frontline staff and volunteers working with Children and Adults at risk of abuse and neglect

➤ **The event will cover the following:**

- What is a Safeguarding Adult Review (SAR) / Domestic Homicide Review (DHR) and Child Safeguarding Practice Review (CSPR) and why do we do them?

- What are the recurring themes from Reviews?
- What are your responsibilities? Why it is important for the whole Kirklees partnership workforce, regardless of role, to understand these responsibilities?

Multi-agency Working and Using the Risk Management Protocol

DoLIC (Deprivation of Liberty in the Community) Forum

➤ **Suitable for:**

This is a forum for staff to bring specific questions/cases to be discussed (adhering to client confidentiality). Due to the nature of a forum not all of the listed outcomes for the course will be met at each forum session. It is likely we will focus in detail on some of the learning outcomes listed rather than cover all at each forum session.

The session will raise awareness of the DoLIC process. We will discuss the 'acid test' and how this can apply within community settings. We will discuss how to record restrictions on care plans, as well as becoming more familiar with the Kirklees guidance and the Court of Protection documentation. The session will support with the completion of necessary and proportionate assessments and the proportionate risk of harm that would occur.

- Have a greater understanding of the DoLIC process within Kirklees
- Be more confident in being able to apply the acid test to community settings
- Be more confident in completing the relevant paperwork for court
- Be aware of when to complete a priority support tool.

DoLS for Professionals

➤ **Suitable for:**

Managers, deputies and health and social care staff who provide care and support and are Managing Authorities in line with the Deprivation of Liberty Safeguards (DoLS).

Entry requirement: A working knowledge of the Mental Capacity Act and Deprivation of Liberty Safeguards is required

To enable participants to have a good understanding of what constitutes a Deprivation of Liberty and are clear about the Deprivation of Liberty Safeguards application and authorisation processes to ensure that there is always a legal authorisation for any deprivation of a person's liberty.

➤ **At the end of the session participants will:**

- State how a Deprivation of Liberty can be identified and give examples
- Explain the difference between “restriction”, “restraint” and “deprivation” within the context of the Mental Capacity Act, and the importance of exploring least restrictive options
- Describe the key features of the Deprivation of Liberty Safeguards (DoLS)
- Explain when a Deprivation of Liberty authorisation should be applied for, and the process for this (including arrangements for community settings and the role of the Court of Protection)
- List the key people / bodies that have responsibilities within the DoLS
- Describe the DoLS assessment process
- Identify the key features of an urgent authorisation and a standard authorisation
- Describe DoLS review and reassessment processes
- Consider relevant case law
- Describe the Liberty Protection Safeguards and their implications for future practice

DoLS in the Community

➤ **Suitable for:**

Managers, deputies and health and social care staff who provide care and support and are Managing Authorities in line with the Deprivation of Liberty Safeguards (DoLS).

Entry requirement: A working knowledge of the Mental Capacity Act and Deprivation of Liberty Safeguards is required.

This session will enable participants to identify when applications need to be made to the Court of Protection to authorise Deprivation of Liberty and to meet the expectations of the Court for making such applications.

➤ **At the end of the session participants will:**

- State how a Deprivation of Liberty can be identified and give examples
- Consider relevant case law
- Identify the necessary evidence for making applications to the Court of Protection to authorise Deprivations of Liberty in the community setting
- Describe the streamlined process known as “Re X” put in place by the Court of Protection
- Develop skills in report writing and preparing evidence for the Court of Protection
- Describe the Kirklees guidance ‘DoLS in the community’ to achieve best practice in assessment and making an application to the Court of Protection
- Consider the Liberty Protection Safeguards and their implications for future practice

MCA - Assessing Capacity, Best Interests Decision Making and Working with Unwise Decisions

Mental Capacity Act Forum

A Safeguarding Adults Review (SAR) is carried out when an adult at risk dies or has experienced serious neglect or abuse and there is concern that agencies could have worked more effectively to protect the adult.

A Safeguarding Adults Review is a multi-agency learning process. It aims to:

- identify and promote good practice
- encourage effective learning
- make recommendations for future practice so that deaths or serious harm might be prevented from happening again
